Dear Ms. Rabe Hasenauer:

This letter is in response to your email correspondence received by this office on May 16, 2017,¹ in which you sought our assistance in obtaining certain records from the Nebraska Oil and Gas Conservation Commission ("Commission"). When we receive correspondence of this nature, our normal practice is to contact the entity involved and advise it of the opportunity to provide a response to this office. In the present case, we contacted the Commission director, William H. Sydow, and advised him accordingly. We received Mr. Sydow's response on May 17, 2017. We considered your correspondence to be a petition for review under Neb. Rev. Stat. § 84-712.03 of the Nebraska Public Records Statutes, Neb. Rev. Stat. §§ 84-712 through 84-712.09 (2014, Cum. Supp. 2016) ("NPRS"). Our findings in this matter are set forth below.

FACTS

According to your petition, in 2014 you requested from the Commission "all letters, emails and reports between the NOGCC and T-Rex Oil." You indicate that Mr. Sydow provided you "a few months [sic] worth which showed regular and frequent communication between himself and T-Rex officers." However, in response to your request for records that were purportedly missing for a six-month period, Mr. Sydow advised that "there had been NO communication for that period of time." (Your emphasis.) You believe this is incomprehensible, and seek our help in retrieving this information.

Your initial correspondence to this office was a forwarded email which you originally sent to Governor Pete Ricketts on May 2, 2017. You sent us a redacted email, with the same public records complaint, on May 17, 2017.

According to Mr. Sydow, your communication with the Commission began in 2014 when you and your husband inquired as to the Commission's recent rulemaking effort. However, Mr. Sydow indicates that you did not submit a public records request to the Commission in 2014. Rather, you made your first public records request on March 17, 2015. Your specific request sought "all letters and correspondence with Terex or T-Rex Corporation to and from the [Commission] and all memos, emails and records of phone calls to and from Terex or T-Rex Corporation during the last 15 months." Mr. Sydow indicates that the Commission filled that request on March 23, 2015, providing you 103 pages of records. On April 22, 2015, you hand delivered a second request to the Commission, in which you requested, among other things,

all documents from Terex or T-Rex Oil from January 2014 until June 2014 and again documents from June 17 to Oct 15, 2014. . . . Also, please include documents from March 10 to April 22, 2015.

According to the Commission's response, dated April 30, 2015, you were provided eight pages from Mr. Sydow's telephone log and certain email which were deemed responsive to your request. Mr. Sydow further stated:

We have had little contact with the company over your time period. No other members of our Commission staff have corresponded with Terex Energy Corporation personnel in any other electronic or written form over the period from March 10 through April 22. To our knowledge, the enclosure contains all records which pertain to Terex Energy Corporation over that time period.²

DISCUSSION

The Nebraska Public Records Statutes generally allow citizens and other interested persons the right to examine public records in the possession of public agencies during normal agency business hours, to make memoranda and abstracts from those records, and to obtain copies of records in certain circumstances. Under those statutes, every record "of or belonging to" a public body is a public record which individuals may obtain a copy of unless the custodian of the record can point to a specific statute which allows the record to be kept confidential. There is no provision in the NPRS that requires a custodian of public records to review documents and create abstracts or other lists, to answer questions or to create documents which do not otherwise already exist.³

Mr. Sydow has represented to this office that you submitted no public records requests to the Commission in 2014, but did submit requests in March and April 2015. He further advises that the Commission produced all of the records which were responsive to those requests. We understand that you find it incomprehensible that no records exist for a particular time frame. However, in the absence of any evidence from you to the contrary, it may be presumed that Mr. Sydow has faithfully performed his official duties, and has provided you all responsive records. *Wolf v. Grubbs*, 17 Neb. App. 292, 759 N.W.2d 499 (Neb. Ct. App. 2009).

When we receive petitions under Neb. Rev. Stat. § 84-712.03 of the NPRS, our focus is to ensure that citizens have not been improperly denied public records. Based on the information we received from you and Mr. Sydow, we are unable to conclude that you have been denied access to public records in any way. Consequently, since no further action by this office is warranted, we are closing this file.

If you disagree with the analysis we have set out above, you may wish to contact your private attorney to determine what additional remedies, if any, are available to you under the Nebraska Public Records Statutes.




