To provide Nebraska's youth an experience of state government and law, the Attorney General's Office is hosting the Attorney General's Youth Conference at the Nebraska State Capitol on Tuesday, April 16, 2019, from 9:30 a.m. to 4:00 p.m.

This year, an appointed number of high school juniors from across the state will be selected to attend. Conference attendees will participate in discussion and debate of current issues, hear from AGO Bureau Chiefs, expand their understanding of the legal process in Nebraska, and eat lunch at the Governor's Residence.

If selected to attend, you will need to be chaperoned by a parent/educator for purposes of transportation to and from Lincoln. If space allows, some sessions will be open to your attending chaperone. Due to limited space, chaperones will be responsible for their own lunch.
