INTRODUCTION

The Nebraska Sexual Assault Payment Program (SAPP) was enacted by the Nebraska Legislature through LB843 and went into effect July 1, 2017 (Nebraska Revised Statute 81-1429.03). In accordance with federal and state law, health care entities may not bill patients for sexual assault kits and forensic evidence collection. Under the SAPP, healthcare providers and facilities may receive reimbursement of up to two hundred dollars for examiner's fees and up to three hundred dollars for facility fees. These exams include collection of forensic evidence, injury identification and treatment along with lab samples to identify disease transmission.

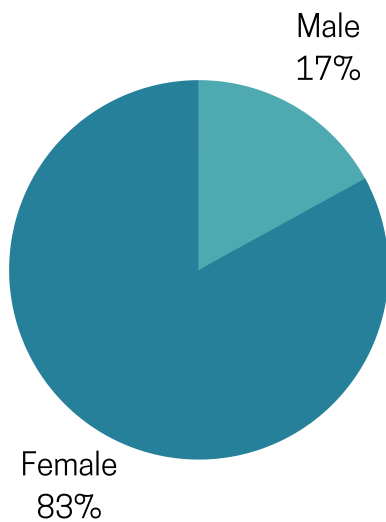
Since its inception, the SAPP has served over 3,564 persons who needed medical examinations. The program has continued to grow to reimburse healthcare entities providing this much needed evidence collection and care.

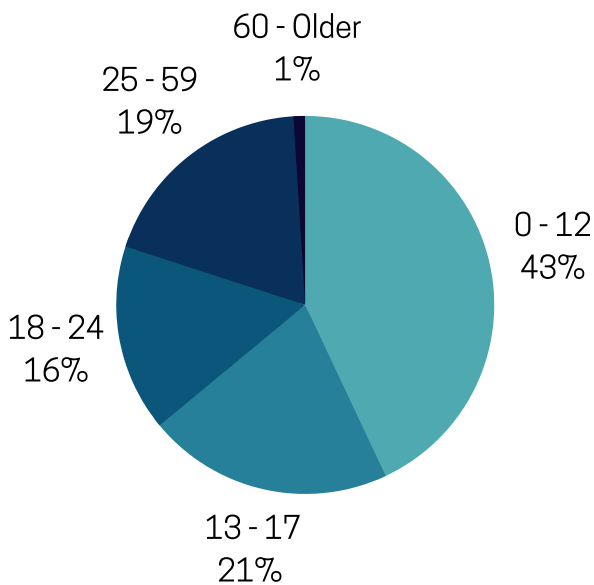
SEXUAL ASSAULT MEDICAL EXAMS STATEWIDE

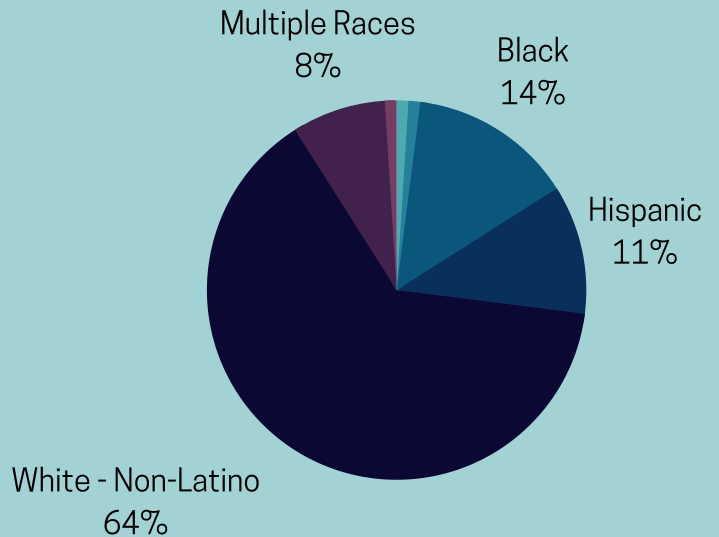

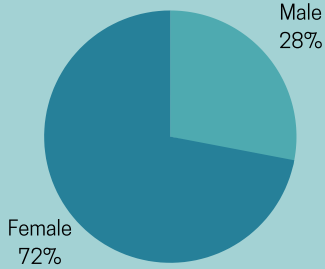

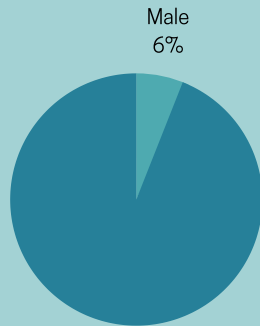
BROKEN DOWN BY AGE & RACE

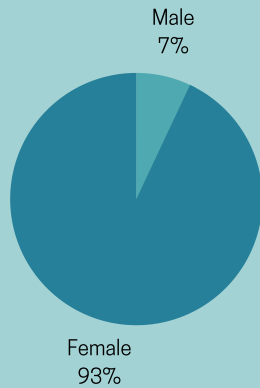
Ages 0 - 12



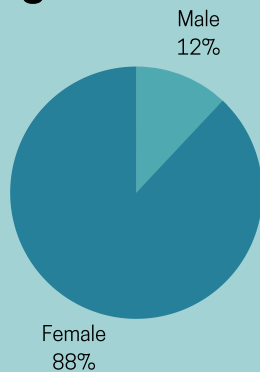
Ages 13 - 17



Ages 18 - 24

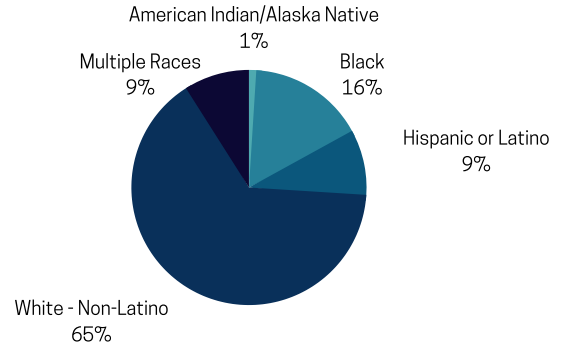


Ages 25 - 59

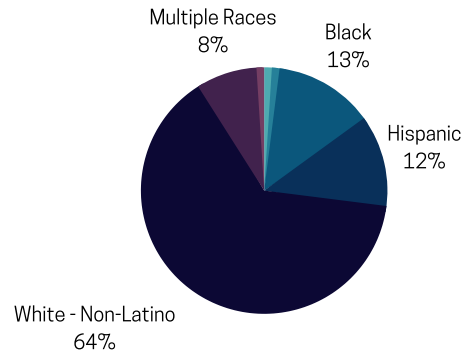

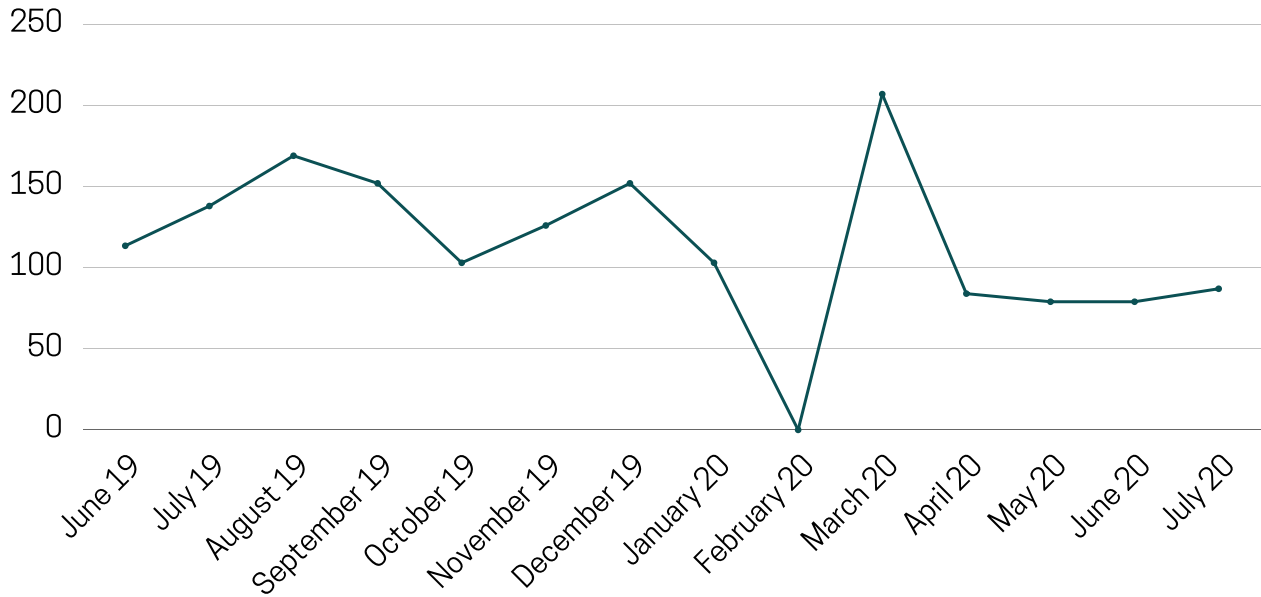

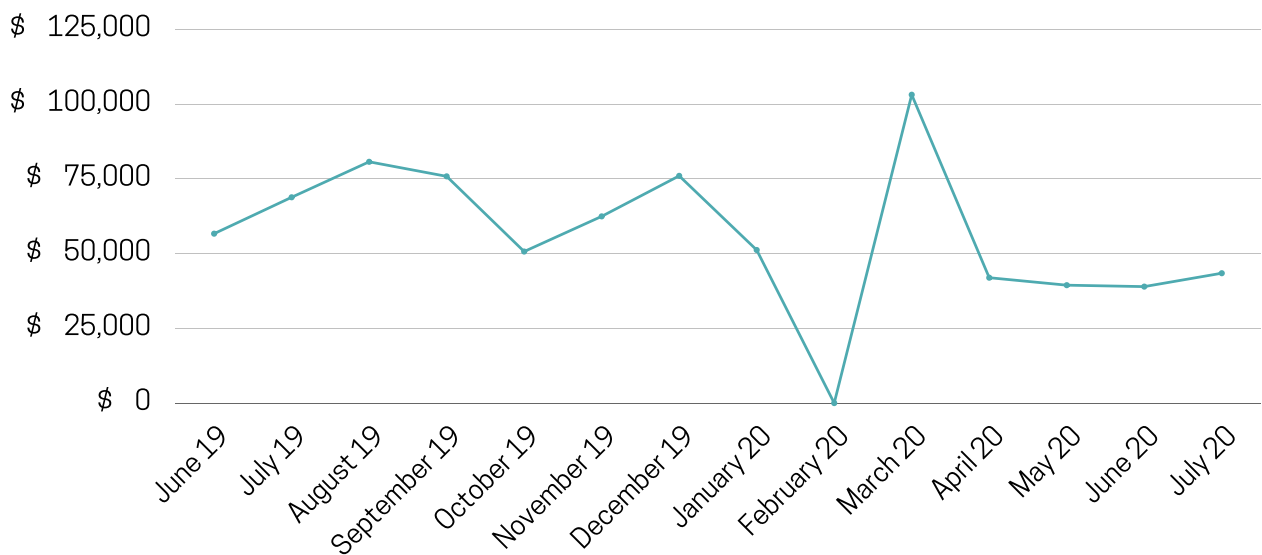

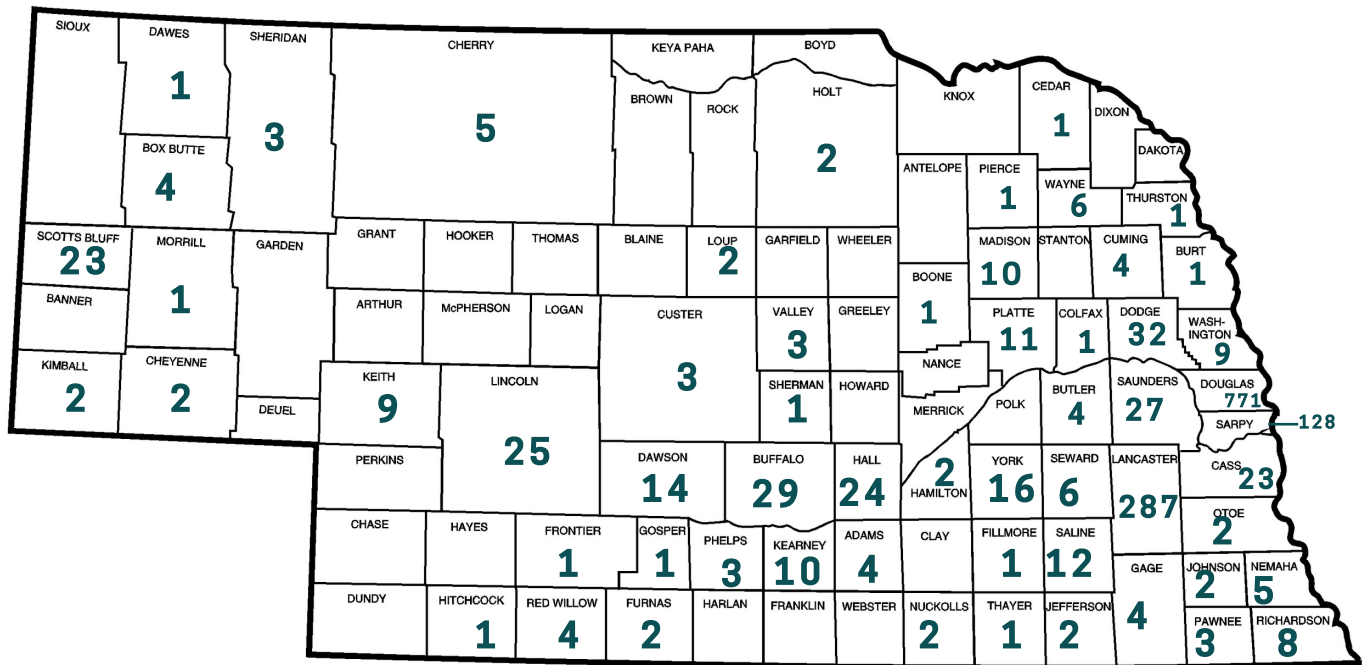
