#### **Attorney General Update**

As Attorney General, I am dedicated to making the State of Nebraska a place where survivors are supported and traffickers are held accountable.

The Nebraska Human Trafficking Task Force (NHTTF) is growing every year. Comprised of law enforcement, prosecutors, healthcare professionals, service providers, advocates, and community members, NHTTF is continuously collaborating to stop human trafficking in Nebraska.

This year, we hosted our largest-ever anti-trafficking event, the Nebraska Human Trafficking Task Force Summit. We had over 200 people attend, and we gained insight from many experts. As a result of the event's success, we will be hosting the 2025 Nebraska Human Trafficking Task Force Summit on September 16th in Lincoln at UNL's Innovation Campus.

Education continues to be a priority for our office. In 2024, a Nebraska human trafficking case went to federal trial. This trial began because patrol officers on the front lines were able to correctly identify human trafficking after attending a previous NHTTF training. Our team is regularly contacted by front-line partners who have attended NHTTF training and know we are here to answer questions, provide direction, or help understand the law.

Stories like these are why we continue our work. By reading this report, you become part of a network of educated Nebraskans combating human trafficking.



Depending on the case, prosecutors may choose to prosecute trafficking defendants with related felony charges to ensure that those who traffic in Nebraska are held accountable.



# **Ongoing Education**

In 2024, the Nebraska Human Trafficking Task Force trained well over 2,000 individuals across Nebraska on understanding human trafficking, recognizing the risk factors and warning signs of trafficking, how to report suspected cases of human trafficking occurring in their community, and other pertinent issues.



#### Hotel, Motel, and High School Training

In 2024, the Nebraska Human Trafficking Task Force created and distributed a <u>video</u> to help hospitality staff recognize and report human trafficking. The Task Force also created a <u>video</u> to educate high school students on the warning signs of grooming and human trafficking.



#### **2025 Human Trafficking Posters**

NHTTF launched a new poster design in 2025. The QR code on the poster directs the public to identify and report human trafficking to law enforcement.

# **Missing and Murdered Indigenous Persons**

NHTTF works to provide healthcare entities with the resources necessary to connect survivors with vital medical and psychological services. In 2024, NHTTF team members collaborated with Twelve Clans Unity Hospital in Winnebago to develop their own forensic nursing team to serve all survivors of trafficking, sexual assault, and domestic violence.



The Missing and Murdered Indigenous Liaison in the Nebraska Attorney General's Office works within the communities to ensure all resources are communicated with the tribes. Given the unique vulnerabilities these communities face, including geographic isolation and historical marginalization, tribal organizations and advocacy groups are working to strengthen protections and provide education about the risks and realities of trafficking.



#### **HALT Fund**

On May 8, 2024, the Nebraska Bankers Association launched the HALT Human Trafficking Fund to support the work of nonprofit and local government organizations throughout the state by providing financial support to those working to eliminate human trafficking in Nebraska.

This partnership formed as a powerful step in the fight against human trafficking in Nebraska. The mission of HALT is to eradicate human trafficking in Nebraska through education, collaboration, and support. # **Legislation Passed in 2024**



During the 2024 legislative session, the Nebraska Unicameral passed LB934, which, in part, will combat the proliferation of child exploitation, human trafficking, and sexual assault content online. Passage of the bill allows the Attorney General to hold online actors and platforms accountable for purveying sexual abuse content, including content that exploits children and trafficking survivors.

The bill is a continuation of the <u>ongoing</u> <u>partnership</u> between the Legislature, the Attorney General, and the Nebraska Human Trafficking Task Force.
